



Public notice for the collection of expressions of interest for student accommodation for international students enrolled in UNITUS international study programs (Civitavecchia campus) for the academic year 2023-2024.

1. PURPOSE AND OBJECT

The University of Tuscia, in order to support out-of-town and international students in finding accommodation in Civitavecchia, has entered into agreements with operators and entities. Currently, there are six available sleeping places at agreed rates in an apartment located at Via Pio IV, No. 20, Civitavecchia, for students in need of accommodation.

2. BENEFICIARIES

- International students enrolled in the Circular Economy and Marine Biology and Ecology degree programs.

3. REQUIREMENTS

- Enrollment in the Master's degree programs in Circular Economy and Marine Biology and Ecology for the academic year 2023-2024.

- Holders of UNITUS scholarships for the academic year 2023-2024.

Accommodation is available immediately.

4. SUBMISSION OF EXPRESSION OF INTEREST

Students meeting the criteria outlined in point 3 may submit an expression of interest by completing the online form to enter into an agreement for the availability of accommodation (sleeping place) at the apartment covered by the University's agreement.

The expression of interest must be submitted exclusively via the form available at this link <https://forms.gle/sJBjGmfF6cjqM2c67>, along with the required documentation, by **March 8, 2024**, at 11:59 PM (Italian time). In case of technical problems, contact the following address: international@unitus.it.

Incomplete or incorrectly completed applications or those received after the deadline or sent via email will not be accepted. In case of multiple applications sent from different email addresses, the first application sent in chronological order will be considered.

5. RANKING AND AGREEMENT

Due to the urgency of accommodation allocation, the University will rank eligible students based on the chronological order of application submission and proceed to enter into an agreement with the top 6 students for a duration of three months. A new notice will be published subsequently for accommodation allocation based on merit and ISEE/ISEUP criteria.

6. DURATION AND RENT

The agreement is valid for 3 months. The monthly rent per sleeping place is €270.00, including utilities. The student will have €810.00 deducted from the scholarship payment due, corresponding to the cost of three months.

7. WITHDRAWAL

Accommodation beneficiaries may withdraw by sending an email to international@unitus.it by March 13, 2024. In case of withdrawal, the sleeping place will be assigned to the next eligible candidate in the ranking.

8. DATA PROCESSING INFORMATION

In compliance with European data protection policy, the collected personal data are processed as described on the following page available (in Italian) at the address [link]. The Administration reserves the right to verify the accuracy of the information provided. Without prejudice to the criminal penalties under Article 76 of Presidential Decree No. 445/2000, in case of fraudulent information, the candidate forfeits the scholarship.
