HAVING REGARD TO Law no. 240 of 30 December 2010

**HAVING REGARD TO** the Statute of the University of Tuscia of Viterbo issued by R.D. no. 480 of 8 June 2012, pursuant to Law no. 240 of 30 December 2010, and amended by R.D. no. 185 of 11 March 2019

**HAVING REGARD TO** the University Teaching Regulations, issued by R.D. no. 823 of 16 October 2012, subsequently amended by R.D. no. 545 of 23 November 2023

**HAVING REGARD TO** the University Regulations for the conclusion of international agreements and access to mobility funds, issued by R.D. No. 496 of 13 May 2015, subsequently amended, most recently, by R.D. No. 675 of 22 December 2022, and in particular Article 2 thereof

**HAVING REGARD TO** the Strategic Plan 2022/2024 resolved at the meetings of the Academic Senate and the Board of Directors held on 19 July 2021 and 21 July 2021 respectively

**HAVING REGARD TO** the A.O. 2024/2026 Strategic Plan approved by the Board of Directors on 31 January 2024 and, in particular, the objectives relating to the enhancement of the international dimension

**HAVING REGARD TO** the Conversion Table of Foreign Securities of the MIUR, Annex 5 to Ministerial Decree N 313 of 20 May 2016

**HAVING REGARD TO** the Programme of activities for internationalisation - academic year 2024/25 approved at the meetings of the B.o.D. and the S.A. of 30 November 2023, which envisages, inter alia, the activation of scholarships totalling € 322,000 to promote the enrolment of international students in three-year degree courses, single-cycle degree courses or master's degree courses delivered in English

**HAVING REGARD TO** the University Guidelines for the promotion of the internationalisation of study courses 2024:

HAVING REGARD TO R.D. No. 153 of 3 April 2024 approving the signing of the Agreement with the Ministry of Agriculture of the Republic of Uzbekistan under which the Ministry of Agriculture of the Republic of Uzbekistan undertakes to finance no. 20 grants to cover travel expenses of 2. 500 per year and no. 15 scholarships in the amount of €7,000.00 (seven thousand) per year for two academic years (2024/25 and 2025/26) and this University is willing to co-finance no. 5 scholarships in the amount of €7,000 per year, in favour of students of Uzbek nationality who intend to matriculate in the a.y.2024 /25 to the following international Master's degree courses: Circular Economy; Forestry and Environmental Sciences; Plant Biotechnology for Food and Global Health;

**HAVING REGARD TO** R.D. no. 208 of 3 May 2024, which decrees the publication of the call for applications for no. 20 scholarships (amount € 7.000/year) and no. 20 grants for travel expenses (amount of € 2,500/year) for no. 20 students of Uzbekistan nationality who will enrol in the following international LM courses: Circular Economy; Forestry and Environmental Sciences; Plant Biotechnology for Food and Global Health or in any additional courses of study activated in the agri-food sector that will be included in the 2024/25 educational offer:

**HAVING REGARD TO** the deadline of 24 May 2024 and the admission requirements set forth in the call for applications;

**HAVING REGARD TO** R.D. no. 245 of 24 May 2024, which authorised the extension of the deadline for the submission of applications until 12.00 AM on 5 June 2024;

**CONSIDERING**, that the number of eligible applications received by the deadline of the extension of the call for applications is lower than the number of the scholarships offered;

**CONSIDERING** the request received from the representatives of the Ministry of Agriculture of the Republic of Uzbekistan to change the minimum GPA value to 22/30 as an admission requirement;

**HAVING HEARD** the Study Course Coordinators and the Ministry of Agriculture contact persons of the Republic of Uzbekistan;

**CONSIDERING**, therefore, that it is appropriate to authorise the extension of the deadline for the submission of applications until 12.00 AM on 1 July 2024;

## **DECREES**

1. In view of the above, to reopen the call for applications for no.20 scholarships (amount € 7.000/year) and no. 20 contributions for travel expenses (amount of € 2.500/year) for no. 20 students of Uzbek nationality who will matriculate in the following international LM courses: Circular Economy; Forestry and Environmental Sciences; Plant Biotechnology for Food and Global Health with the deadline for applications on 24 May 2024 at 12.00 AM and to change the minimum GPA value to 22/30 as an admission requirement;
