My main area of research is policy evaluation in the agricultural sector, with a particular focus on evaluating producer organisations (POs) in the olive oil sector.

A first research project has been initiated to analyse whether the new configuration of POs under the Common Agricultural Policy (CAP) 2023–27 can attract olive growers and whether existing members see benefits in pursuing new collective actions. The Discrete Choice Experiment (DCE) is being used as a methodology. The study's theoretical framework was identified in the literature on hybrid organisations to establish a connection between new CAP objectives and the theoretical forces that motivate this organisational choice.

A second piece of research aims to identify and measure the impact of POs on the economic, environmental and social performance of the sector through counterfactual approaches. The FADN database will be used for this purpose, as it provides representative data on three levels: region, economic dimension and technical and economic classification.
