INTRODUCTION – THE ERASMUS PROGRAM 2021-2027

The study mobilities for the academic year 2025/2026 are regulated by the provisions of the new seven-year Erasmus+ program (2021-2027).

Article 1 – GENERAL INFORMATION

1.1. Objectives

The Erasmus+ Study Mobility Program allows students to spend a continuous study period at a European university that has a partnership agreement with the University of Tuscia. Students participating in the mobility program receive financial support, have the opportunity to attend courses, and use the facilities available at the host institution without additional tuition fees (except for small contributions that local students are also required to pay). They are also guaranteed full academic recognition of the study activities successfully completed abroad, provided they are approved in the Learning Agreement.

The Erasmus+ Program offers students the opportunity to experience different cultures abroad, explore new higher education systems, and meet young people from other countries, thus actively contributing to the European integration process.

At the end of the mobility period, the recognition of successfully completed courses at partner institutions is ensured through the European Credit Transfer System (ECTS), which applies to both grades and credits. It is important to note that at the University of Tuscia, 1 CFU (Credito Formativo Universitario) corresponds to 1 ECTS.

1.2. Participating Countries in the Erasmus+ Program

Students can carry out a study mobility period at a partner university in one of the following Erasmus+ participating countries:

- European Union Member States: Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, and Sweden.
- European Economic Area (EEA) Countries: Iceland, Liechtenstein, Norway.
- **Candidate Countries for EU Membership**: Turkey and North Macedonia (formerly the Former Yugoslav Republic of Macedonia).

1.3. Mobility to the Country of Origin

Students who hold citizenship of an Erasmus+ participating country and are enrolled at the University of Tuscia are eligible for mobility at a university in their country of origin, provided they are not currently residing in that country. However, priority will not be given to them in the selection process. Additionally, before confirming acceptance of the exchange placement, they must obtain prior approval from the host university.

1.4. Types of Mobility

There are two types of mobility: **long-term mobility (LONG MOBILITY)** and **short-term mobility (SHORT MOBILITY)**.

1. LONG MOBILITY

This type of mobility is available to students enrolled in a first-, second-, or third-cycle degree program at the University of Tuscia. It takes place at partner universities based on signed agreements. Each long mobility must have a mandatory minimum duration of **2 months (60 days)** and a maximum duration of **6 months (180 days)**. It must take place between **June 1**, **2025, and July 31, 2026**, and must be continuous. The length of the stay abroad is determined by the agreements with the host university.

2. SHORT MOBILITY

According to the Erasmus 2021-2027 program, only students enrolled in **doctoral programs** or students enrolled in **first- and second-cycle degree programs** who participate in **Blended Intensive Programs (BIP)** in which the University of Tuscia is a partner, are eligible for short mobility.

The mandatory minimum duration of short mobility is **5 days**, and the maximum is **30 days**. It must take place between **June 1**, **2025**, and **July 31**, **2026**, and must be continuous.

Short mobility must be authorized by the host institution. Doctoral students may choose to undertake either long-term or short-term Erasmus mobility at their designated destinations.

1.5 Financial Contribution for Short- and Long-Term Mobility

The financial contribution provided for Erasmus+ study mobility students helps cover the costs of an overseas stay.

The funding consists of:

• European Union Contribution for Long-Term Mobility

The amount is allocated on a monthly basis and is calculated based on the actual length of stay abroad. It varies according to the destination country groups (defined by the European Commission) based on the cost of living, as shown in the table below

• Additional Grant for Candidates with Fewer Opportunities in Long-Term Mobility

Students with fewer opportunities include those in one or more of the following conditions:

• Socioeconomic disadvantage;

• Physical, mental, or health-related conditions.

Students and recent graduates with socioeconomic disadvantages are identified under Ministerial Decree 204/2023, which determines that for the academic year 2024/2025, they are those with an Equivalent Economic Situation Indicator (ISEE) of € 27,726.79 or lower.

Eligible candidates receive an additional € 250.00 per month, in addition to the individual Erasmus+ study mobility grant, as shown in the table below:

To determine eligibility for the additional individual grant, the ISEE and/or ISEEUP submitted during enrollment/registration for the 2024/2025 academic year will be considered.

This information must be available in the GOMP portal before accepting the terms of the Financial Agreement. Otherwise, the additional grant cannot be assigned.

- Candidates with physical, mental, or health-related conditions can access special EU funding based on actual costs incurred. For further details, please contact the International Mobility and Cooperation Office.
- European Union Contribution for Short-Term Mobility

The Erasmus+ grant for short-term mobility ("Short term") is calculated according to the following table:

• Candidates with fewer opportunities in short-term physical mobility receive a one-time additional grant, in addition to the Erasmus+ individual contribution, as indicated in the following table:

• University of Tuscia Additional Contribution

This amount has been approved by the Board of Directors on 31.10.2024 based on available budgetary funds. It will be granted to regularly enrolled students who:

- Have socioeconomic disadvantages;
- Are undertaking Erasmus Study Mobility for a long-term period (at least 2 months);
- Earn at least 12 ECTS during the mobility period within the standard course duration.

The grant amount will be allocated based on income brackets (ISEE and/or ISEEUP) as indicated in the table below:

Students and recent graduates with socioeconomic disadvantages are identified under Ministerial Decree 204/2023, which determines that for the academic year 2024/2025, they are those with an Equivalent Economic Situation Indicator (ISEE and/or ISEEUP) of € 27,726.79 or lower.

To determine eligibility for the additional individual grant, the ISEE and/or ISEEUP submitted during enrollment/registration for the 2024/2025 academic year will be considered.

This information must be available in the GOMP portal before accepting the terms of the Financial Agreement. Otherwise, the additional grant cannot be assigned.

IMPORTANT:

• All students, PhD candidates, and specialized trainees who are exempt from submitting ISEE and/or ISEEUP for tuition fee purposes must still request and upload the ISEE and/or ISEEUP

for university financial aid purposes for 2024 on the GOMP portal to be eligible for the additional M.U.R. grant.

- The University additional grants will not be awarded to students enrolled beyond the first year of extended study ("fuori corso"), considering the initial enrollment year at the University of Tuscia, even in the case of a course transfer.
- Students who fail to earn at least 12 ECTS recognized in their academic records by 31/07/2026 will be required to return any M.U.R. additional grant already received, and any related supplementations will be canceled.

Academic recognition must be completed exclusively through the digitalized procedures available in the personal GOMP system. The above limitations do not apply to PhD candidates and specialized trainees.

1.6 Tax Treatment of the Erasmus+ Grant

Pursuant to Article 1, paragraph 50, of Law No. 208 of 28.12.2015, international mobility grants are subject to the exemptions provided for in Article 1, paragraph 3, of Decree-Law No. 105 of May 9, 2003, converted, with amendments, by Law No. 170 of July 11, 2003, unless further legislative changes apply.

1.7 Travel Grant

Under Key Action 1 of the Erasmus+ 2021/2027 program, the use of green transport—i.e., low CO2 emission travel modes—will be encouraged to make international mobility more inclusive and sustainable.

Therefore, a "Green Travel Grant" will be awarded to those who use sustainable means of transport (such as trains, car-sharing, and buses) to reach their destination.

The grant will be awarded at the end of the Erasmus mobility period and will be paid upon submission of receipts proving the actual green travel expenses incurred.

Participants opting for sustainable travel will be entitled to:

- a one-time TOP-UP grant of €50.00;
- a daily allowance corresponding to the daily amount of the monthly grant. The allowance will be granted for each day of green travel (both outbound and return) necessary to reach the destination, for a maximum of 4 days.

1.8 Disbursement of the Grant

The Erasmus+ grant (comprising the European Union contribution and the additional contribution from the University of Tuscia) will be disbursed in two installments, subject to the accreditation of funds by the Erasmus+ National Agency Indire and the allocation of co-financing in the University's budget.

The grant disbursement procedures and the minimum conditions defined by the European Commission to receive the contribution are specified in the Erasmus+ Financial Agreement, which each student signs with the University of Tuscia. The deadline for departures in the first semester is August 31, 2025, while for the second semester, it is December 31, 2025.

The grant payments will be made exclusively via credit transfer to an Italian bank or postal account (or a prepaid card with an IBAN) in the name of the beneficiary student.

The Erasmus+ grant (comprising the European Union contribution and any additional contribution from the University of Tuscia) will be disbursed in two installments:

- an advance payment of 80% of the awarded grant amount, based on the length of stay, will be made within 30 days of signing the aforementioned agreement. However, the student must send a document with the arrival date at the host institution to confirm the start of mobility;
- the remaining 20% balance will be disbursed after the International Mobility and Cooperation Office has received the final certificate of stay issued by the host university, along with the transcript of records listing the completed exams and earned ECTS credits.

The final grant payment is also conditional on the completion of the online Beneficiary Report, which is automatically sent through the Beneficiary Module, the European system for managing mobility projects.

If the Beneficiary Report is not submitted, the participant will be required to return the entire grant.

It is also specified that the Transcript of Records must be submitted even in the case of failed exams.

Art. 2 REQUIREMENTS AND PROCEDURE FOR SUBMITTING THE APPLICATION

2.1. Requirements for participation in the selection

Students who meet the following criteria are eligible to participate in this call for the allocation of 114 Erasmus+ Mobility for Study contributions, each lasting 6 months:

- Students who, at the time of submitting the application, are enrolled in Bachelor's, Master's, or PhD courses at the University of Tuscia for the academic year 2024/2025, regardless of nationality (see Article 1.3), and who meet all the requirements regarding credits and the average grades as specified in Attachment 1 of this call "Evaluation Criteria."
- Students must have a language proficiency equivalent to at least B1 level in the language(s) of the destination country or in a language accepted by the host institution as the working language, as stated in Article 2.3.

Students currently enrolled in a Bachelor's course, intending to graduate before the departure date for the Erasmus+ mobility, and applying to study part of their first year in a Master's program abroad, must be enrolled in a Master's program at the University of Tuscia at the time of departure, otherwise, they will lose the scholarship and the right to go abroad. These students must prepare the Learning Agreement (study plan to be followed abroad) for the courses related to the Master's degree they will enroll in.

PhD students can participate with the authorization of the course/school coordinator. PhD students receiving a doctoral scholarship may use the additional funding for the stay abroad, which will be combined with the Erasmus+ grant from the European Commission. According to current regulations on the prohibition of double funding and the rules regarding compatibility with the

National Recovery and Resilience Plan (PNRR), it is specified that doctoral scholarships funded by PNRR funds do not allow receiving multiple EU community grants for the same type of activity.

Failure to meet any of the above requirements will result in exclusion from the selection process. Candidates are admitted to the selection subject to verification of the required eligibility criteria. The University of Tuscia can exclude candidates from the selection process at any time if they fail to meet the eligibility criteria specified in this call.

It is important to note that during the mobility, Erasmus students cannot obtain their final degree at the University of Tuscia.

ATTENTION: IF MORE FUNDS BECOME AVAILABLE, THE RANKING WILL BE EXTENDED BEYOND POSITION NO. 114.

2.2. Incompatibility

Students applying for the Erasmus+ Mobility for Study call:

- Can receive an Erasmus grant for each cycle of study (Bachelor's, Master's, and PhD) for a total period of no more than 12 months per cycle; for single-cycle degrees, the maximum period is 24 months. Those who have already participated in mobility under the Lifelong Learning Programme 2007-2013 (Erasmus Study, Placement, or Leonardo da Vinci), Erasmus+ 2014-2020 (Study, Internship, or International Credit Mobility), or Erasmus Mundus, or who have already been selected for mobility for Traineeship or to non-European countries (International Credit Mobility), and are applying for the same study cycle, are eligible for selection as long as the total duration of the previous mobility and the one they are applying for does not exceed 12 months. Internship months after graduation are counted within the study cycle to which the candidate was enrolled at the time of application.
- Cannot receive other EU-funded grants for stays abroad (including grants for attending Joint Master Degrees – former Erasmus Mundus Action 1) that overlap, even partially, with the Erasmus+ internship period (to be declared upon acceptance of the grant);
- International incoming students who benefit from the Erasmus Mundus Action 2 scholarship and are enrolled in Master's courses cannot simultaneously receive the Erasmus Mundus Action 3 scholarship and the Erasmus contribution. For EMA2 projects that allow this, students may suspend the Erasmus Mundus scholarship if they win the Erasmus contribution, after informing and obtaining approval from the project coordinator.

2.3. Language Skills

Language skills must be declared using Attachment 2 - Self-Certification - available on the University website at: <u>https://www.unitus.it/internazionale/studiare-all-estero/erasmus/</u>

At the time of submitting the application, candidates should preferably already have the language skills of the destination country or a language accepted by the host institution as the "working language" at the level required by the host institution, as listed in the destinations section.

If the student has an international language certificate according to the Common European Framework, they may upload it to the portal as an attachment to their application.

Students who cannot demonstrate adequate language proficiency through the methods described above must take a language assessment test at the University Language Center (CLA) to determine

their level of preparation, according to a schedule communicated by the Mobility and International Cooperation Office. Following the evaluation test, students who do not achieve the required level for departure must attend a mandatory preparatory course before departure (the course will be provided free of charge by the University through the CLA).

For students who demonstrate they have the necessary level for mobility through the test, the preparatory course is optional, although strongly recommended.

Students who declare in Attachment 2 that they have no knowledge of the language for the destination country will not need to take the assessment test but must attend the mandatory preparatory course before departure.

2.4. OLS – Online Linguistic Support (OLS)

Language learning is one of the goals of the Erasmus+ program to support linguistic diversity and intercultural skills development. The Erasmus+ Program offers students the opportunity to improve their language skills before and during mobility through free online courses, available via the new EU Academy platform, at the following link: https://academy.europa.eu/local/euacademy/pages/course/community-overview.php?title=learn-a-new-language

Students and recent graduates selected for Erasmus mobility to a Program Country or a thirdcountry not associated with the Program (Key Actions KA131 and KA171) for mobility lasting more than 14 days must take an initial language proficiency test in the language of the mobility before the start of the mobility, unless there is a justifiable exception, such as the language not being available in OLS. Through the new OLS, students and recent graduates can choose one or more languages, without restrictions on the number of courses, and will be able to test their language proficiency level during or after mobility. Currently, the available languages are: Italian, English, Spanish, German, and French, from A1 to B2 level. The service will gradually include all 29 languages at all learning levels.

2.5 Choice of Destinations - Consult the List of Available Offers

Students can select their destination from universities with which the University of Tuscia has signed Erasmus bilateral agreements, choosing the ISCED disciplinary code available for their course of study.

ATTENTION: The following destinations, with universities consorted with the University of Tuscia under specific Double Degree agreements, will be given priority to students enrolled in the corresponding degree programs, in compliance with the specific requirements outlined in the agreements and verified with the academic coordinator of the agreement.

The International Mobility and Cooperation Office will ensure that these destinations are correctly assigned. It may be necessary to intervene in the automatic allocation of destinations.

2.6 Choice of Destinations - Check for Preclusive Requirements

After identifying the destinations of interest, students must check the partner institutions' websites to ensure there are no preclusive conditions, such as close or expired application deadlines, high language requirements, or incompatibility with the educational offer.

It is noted that partner universities may not accept students even if they have been selected by the University of Tuscia.

2.7 Activities to Be Performed Abroad and Learning Agreement

The activities allowed during the mobility period, to be included in the Learning Agreement to be prepared before departure, are:

- Educational activities (courses) and related assessments (exams).
- Preparation of the thesis (Bachelor's and/or PhD).
- Internships (only if provided by the educational program).

Similarly, PhD students must agree on the training path abroad with the PhD coordinator. For all academic aspects of the mobility, students should refer to the Erasmus+ Department Coordinators (see Attachment 3, available on the university website).

ATTENTION: During the mobility period, Erasmus students cannot take exams or obtain their final degree at the University of Tuscia.

2.8 Recognition

The period of study abroad is an integral part of the study program at the University of Tuscia. It must have full academic recognition, meaning that the University of Tuscia must recognize the period of study abroad (without additional program integrations or exams) as corresponding and substitutive to an equivalent period of study at the university, even if the course content is not identical.

In evaluating the studies completed, the value and weight of all the educational activities typical of the host university are taken into account.

However, students cannot have credits recognized for courses that are similar to those already taken at the University of Tuscia.

At the end of the Erasmus period, the host institution must issue the following to the International Mobility and Cooperation Office:

- A **Transcript of Records** for the study program carried out according to the Learning Agreement.
- A certificate indicating the dates of the mobility period.

The University of Tuscia rewards students who participate in the Erasmus Mobility Program by adding 1 point to the final score at graduation.

2.9 Application Submission

Students interested in applying must complete the application form through the Gomp student portal by accessing the following link:

Once logged in, the study abroad call can be accessed via: Home > Career, Study Plan, Exams > International Mobility > Study.

It is important to note that when filling out the application, students must indicate any months previously spent abroad on Erasmus mobility. Please refer to Article 2.2.

Erasmus mobility periods completed virtually from the student's usual country of residence starting from the 2020/2021 academic year **will not** count towards the maximum number of Erasmus mobility months per study cycle.

While filling out the application, candidates can select all available destinations for the ISCED codes linked to their course of study and rank them by preference.

Students enrolled in a PhD program, with the University of Tuscia as their administrative headquarters, may only apply for destinations listed as "PhD student."

The deadline for applications is **31 March 2025, 23:59**.

Please note:

- Each candidate can submit **ONE application only**.
- Students enrolled in Master's programs, Specialization Schools, or Single Courses **cannot** participate in the selection.
- No paper documentation is required for submission.

By the deadline, the International Mobility and Cooperation Office will organize an informative webinar for all students interested in applying.

Article 3: SELECTION PROCEDURES

3.1 Evaluation Criteria and Rankings

The available spots will be assigned based on the evaluation criteria outlined in Attachment 1 of the Call:

- In case of a tie, priority will be given to the candidate who has not yet benefited from Erasmus+ mobility, with or without financial support.
- If there is still a tie, priority will be given to the candidate who is younger (L. 16/06/98 n. 191, art. 2).

Each student can check the destination they have been assigned by logging into their portal. If the destination is suitable for their mobility needs, the student can accept the assignment within **5 days**. If they do not accept it, they can compete for a different available destination. By accessing their portal again, the student can check their status regarding the new destination and accept it within the given time frame.

Failure to accept a destination will be considered a renouncement of mobility, and students further down the list can take the vacant spot. Renouncing the assigned destination does **not** result in any academic penalties or affect future application processes.

Article 4: DEADLINES AND PROCEDURES FOR SUCCESSFUL CANDIDATES

By **2 May 2025**, students must complete their Learning Agreement with the support of the Erasmus+ Department Coordinator.

Departures typically occur during:

- First semester: September/October 2025
- Second semester: January/February 2026

After confirming the acceptance of the exchange position, selected students for an Erasmus+ mobility scholarship must:

- Contact their Erasmus+ Department Coordinators (see Attachment 3) to agree on the period to spend abroad, choosing between the 1st or 2nd semester, and verify the academic activities to be carried out during the stay abroad.
- Visit the host foreign university's website to gather detailed information about the academic offerings and download the necessary documentation.
- Sign the Mobility Agreement within the established deadlines.

Through the acceptance of the destination, the GOMP system communicates the student's name to the partner universities.

Note: International students holding an Italian residence permit must complete the mobility within the validity period of their residence permit.

Article 5: INSURANCE COVERAGE

Health Insurance

Each beneficiary must personally arrange for health coverage. If the candidate has the European Health Insurance Card (EHIC), they automatically have access to National Health Service benefits in all EU countries (for more information, visit: http://ec.europa.eu/social/main.jsp?catId=559&langId=it; www.sistemats.it). However, the EHIC or private insurance coverage may not be sufficient, especially in cases of repatriation or specific medical interventions. In such cases, additional private insurance might be necessary.

Civil Liability and Accidents

Insurance coverage (civil liability and accidents) is provided by the University. The University has contracted the following policies, which will be renewed upon expiration:

In case of accidents or other incidents with a prognosis of more than 3 days at the host foreign university, students must immediately contact the International Mobility and Cooperation Office by email at erasmus@unitus.it.

Article 6: PERSONAL DATA PROCESSING

The personal data provided by candidates will be collected by the University of Tuscia. In accordance with EU Regulation 679/2016 "General Data Protection Regulation," the Data Controller is the University of Tuscia, and the data processing is managed by the International Mobility and Cooperation Office. The data will be collected and processed solely for the purposes of managing the selection. Providing this data is mandatory for the evaluation of participation requirements, and failure to provide it will result in exclusion from the selection process.

Article 7: PROCEDURE RESPONSIBLE

Article 8: FINAL PROVISIONS

All activities and related funding under this call are governed by the agreement no. 2024-1-IT02-KA131-HED-000196723 for the Erasmus Mobility Program for the 2025/2026 academic year, signed between the Erasmus+ National Agency INDIRE and the University of Tuscia.

Subsequent official provisions from the Erasmus+ National Agency INDIRE that differ from the content of this call shall take precedence over the rules in this call. The Erasmus+ call for mobility scholarships for study stays abroad in the 2025/2026 academic year is part of the mobility program for students at partner universities in the European Community and has been implemented with

the support of the European Commission. However, the content of this call does not necessarily reflect the position of the European Commission or the Erasmus+ National Agency INDIRE and does not make them responsible in any way.

Article 9: REFERENCE PROVISION

For matters not explicitly addressed in this call, the provisions of the regulations mentioned in the preamble of the decree publishing the call, as well as the relevant national laws, apply.
